- Monthly Fee: \$150
- Paid Today: \$150, with remainder of membership paid in 11 monthly installments on or after the 1st day of each month.
- **Membership is for 12 months from the date of first payment.**
- Membership will auto-renew at the end of annual term for \$150/month paid on or after the 1st of each month.
- **To cancel membership after the initial 12 month term, members must submit a written termination request to info@anuaesthetics.com. 30 days notice is required, and as such, the next month will be charged if the next payment is due in under 30 days.**
- Monthly membership payments are **non-refundable**.
- FREE monthly treatments **will expire** on the last day of each month and will not roll over to the next month.
- If you 'no show' or late cancel your scheduled free monthly treatment appointment within 24 hours of the appointment, you forfeit that service for the month and will not be allowed to schedule your free service for the remainder of the month.
 - *Late cancellations and no shows result in lost revenue for aNu and loss of income for the staff member as we do not double book our appointments to best serve you. It also does not allow another patient the opportunity to have your appointment time. As a small local business and for our staff, we kindly ask that you always give us at least 48 hours so we can fill the opening and help accommodate our other patients.*
- aNu Aesthetics and Optimal Wellness reserves the right to change clinic policies, regulations, and pricing upon providing reasonable notice via email to the email address on file for the Member.
- If my credit card information changes, I am required to inform aNu Aesthetics and Optimal Wellness prior to my next payment date and update my information to avoid late fees.
 - *Late fees: \$25 per month will be charged if we are unable to process your credit card due to expiration, change of information or canceled card. We will attempt to reach you by phone and other methods, but it is ultimately the*



members responsibility to contact us with updated information within 30 days. This fee will be charged each month after the first 30 days until updated information is received. We will also still need to collect monthly membership fees each month until the contract ends (> 1 year and by written notice). Therefore, once credit card info is updated, these late fees and past payments will be due and charged accordingly.

_____ **Termination**

After (12) months, a 30 day written notice before your next scheduled payment is required to cancel a monthly membership plan, and as such, the next month will be charged if the next payment is due in under 30 days. No refunds will be issued after monthly membership dues have been charged or paid in full.

_____ **Auto-Renewal**

Your membership will automatically be renewed at the end of the 12 month annual term, unless you submit a written request to terminate your membership as above.

_____ **Early Termination**

If there are **severe** extenuating circumstances and it becomes necessary to request termination of my membership prior to the end of the initial 12 month period, I understand **there will be a minimum \$500 Early Cancellation Administrative Fee which will be paid via your Spa Bank first and if there is any remaining balance due it will be charged to credit card on file.** Requests for early termination must be submitted in writing to the above email address. Early termination is not final until/unless approved by the Owner/Administrator. Additionally, if early termination is approved, members are no longer eligible for the free monthly service or the 10% discount on products or services. **IF APPROVED**, 30 day written notice before your next scheduled payment is required to cancel a monthly membership plan, and as such, the next month will be charged if the next payment is due in under 30 days.
